

Dog Training Agreement

Owner Services: Bing's Boarding, LLC ("Bing's") agrees to provide training for Owner and K-9 Client. The goal being to teach Owner how to work with K-9 Client as part of the training program, to ensure continued reinforcement training when K-9 Client is not with Bing's, and following training completion. Owner understands that he/she and members of the household must follow Bing's instructions without modification, work with the K-9 Client daily as recommended, and constantly reinforce training being given to K-9 Client.

No Warranties or Guarantee: Bing's Boarding, LLC will make very reasonable effort to help Owner achieve training and behavior modification goals but makes no guarantee of K-9 Client's performance or behavior as a result of providing this training. The Parties confirm that, except for that which is specifically written in this Agreement, no promises, representations or oral understandings have been made with regard to K-9 Client or anything else, to include training achievements of K-9 Client, without limiting the generality of the foregoing. Owner acknowledges that Bing's has not represented, promised, guaranteed or warranted that K-9 Client will never bite, that K-9 Client will not be dangerous or vicious in the future, that K-9 Client will not exhibit the same or other behavioral problems, or that the results of the training will last for any particular amount of time.

Cancellation Policy: If Owner fails to give at least 24 hours cancellation notice, or is not present at time of scheduled appointment, deposit shall be forfeited. For a packaged deal, the class (session) will still be counted as one training class (session). One make-up class per packaged deal will be allowed as long as the Owner cancels/re-schedules according to the Cancellation Policy.

Liability: If K-9 Client causes property damage, or bites or injures any dog, animal, or person (including but not limited to the Bing's Boarding, LLC trainer or Bing's agents), during or after the term of this Agreement, then Owner agrees to pay all resulting losses and damages suffered or incurred, and to defend and indemnify Bing's and Bing's agents from any resulting claims, demands, lawsuits, losses, costs or expenses, including attorney fees. If K-9 Client is injured in any manner during or after the term of Agreement, Owner assumes the risk and agrees that Bing's Boarding, LLC or its agents will not be held responsible for any resulting injuries, losses, damages, costs or expenses.

Termination: At Bing's Boarding, LLC's sole discretion, Bing's responsibilities hereunder shall terminate if (a) in the Bing's trainer's sole judgment K-9 Client is dangerous/aggressive to the trainer or any other person or animal, or interferes with the training of other dogs, or (b) Owner breaches any term or condition of this Agreement. Upon termination in accordance with the foregoing, Bing's Boarding, LLC's responsibilities shall terminate but all other provisions of this Agreement shall continue in full force and effect. Bing's will offer a continuance or group training class for the Owner and can provide a replacement K-9 Client for the purposes of training. This Agreement is binding upon the Owner, spouse of Owner and household members. This Agreement supersedes all prior discussions, representations, warranties and agreements of the Parties, and is the entire agreement between Owner and Bing's Boarding, LLC.

Entire Agreement; Modification; Binding Effect: This Agreement constitutes the entire agreement between the Parties and supersedes any prior understandings between the Parties with respect to the terms and conditions of this Agreement and the training of K-9 Client. No modification of this Agreement will be valid unless it is made in writing and signed by all Parties. This Agreement is binding upon Owner and Owner's heirs, assigns, successors, personal representatives and executors.

Choice of Law: This Agreement shall be governed by the laws of the State of Alabama and the Parties hereto consent and agree that any action brought to enforce any provision of this Agreement shall be brought in the courts of Madison County in the State of Alabama. Owner acknowledges that he/she/they have read this Agreement and understands it is a legally binding contract. Owner has received a copy of this executed Agreement upon request and agrees to abide by all its terms and conditions.
